The Deputy Speaker, (hon. Adamson Lanyasunya): Hon. Members, in the schedule of response to statements, it is notified that pursuant to Standing Order number 41 (2) (c), the Speaker has approved the following statements tentatively for Tuesday the 16th, which is today's session, to be responded as follows:

1. Response to statement number 039/2016 from the Chair for Physical Planning, Housing and Urban Development concerning the leasing of the Maralal Energy Company to operate in Nyiro ward by hon. Jonathan Lemoosa.
2. Response to statement number 041/2015 from the Chair for Medical Services, Public Health and Sanitation concerning extraneous allowances for community health workers by hon. Modester.
3. Response to statement number 001/2016 from the Chair for Agriculture, Livestock and Fisheries concerning the vaccination of livestock against EPR, CPP and foot and mouth disease in Longewan by hon. Shadrack Lesoipa.
